CDI Invitations: Foreign Athletes will be invited by the OC through their home NF. All invitations must be received by the OC by the definite entry date.

CDI Horse Inspection: For all CDI horses on Thursday at 3:00PM. Location is behind FEI BARN 4. CDI Freestyle sound check will be at 4:15PM.

All CDI horses stabling in the secured FEI barns MUST meet with the FEI VET upon arrival for official check-in to FEI Barn.

CDI-W: Grand Prix Class 500 qualifies for Class 501 Grand Prix Freestyle (must receive at least a 60% in the GP) and is compulsory for the 15 best combinations from Class 500. Limited to 1 horse per rider. Class 501 Grand Prix Freestyle "FEI Degree of Difficulty" – Floorplan will be used.

CDI3*: Class 502 Grand Prix qualifies for Class 503 Grand Prix Special or for Class 536 Grand Prix Freestyle (must receive at least a 60% in GP) and is compulsory for the 15 best combinations from Class 502. Limited to 2 horses per rider for the Grand Prix, highest scoring horse moves on to GPF or GPS.

CDI2*: Intermediate A / Intermediate II. Limit to 1 horse per rider.

CDI1*: Small Tour B, Prix St. Georges, Intermediate I, Intermediate I Freestyle. Limit to 2 horses per rider, except for Class 508 Intermediate Freestyle is limited to 1 horse per rider (2 horse if less than 18 combinations). Freestyle is not compulsory.

CDIJ, CDIY, CDIP: Freestyles are not compulsory. JR/YR, and Pony limited to 1 horse per rider.

CDICh: All Children entries must ride Team Test to qualify for the Individual Test. Limited to 1 horse per entry.

CDIU25: Intermediate II 16-25, Grand Prix 16-25, Grand Prix Freestyle 16-25. Freestyle is not compulsory. Limited to 1 horse per rider.

CDIAm: Athletes from 26 years. Athletes must have no ranking on the FEI Dressage World Ranking List at the date of definite entry. Athletes living abroad may compete in Events of their host country, with permission from the NF of their host country. FEI Passport not required if competing in their home country, however these horses must have a National Passport and be registered with their NF, be identifiable by diagram, and have a valid vaccination certificate. Limited to 1 horse per rider.

CDIYH: Limited to 1 horse per rider and must have a valid passport.

Passports: All CDI horses with passports stabling in the secured FEI barns MUST follow FEI protocols. In accordance with Art. 1029 and 1031 of the FEI 2022 Veterinary Regulations, as of January 2022, ALL Horses competing at ALL FEI Events worldwide must fulfill the Horse Health Requirements via the FEI HorseApp.

Main Requirements:

There are three main requirements you must fulfil for each horse:

- 1.) Take two daily temperature readings for every horse that will be presented at an FEI Event for the three days leading up to the day of arrival and enter these recordings in the FEI HorseApp. For clarification, the three days prior to your arrival at the FEI Event are calculated as per this example: if you plan to arrive at the event on Thursday, you will have to enter the temperatures for the three preceding days, which are Monday, Tuesday and Wednesday. To avoid violating the Horse Health Requirements, temperatures should be entered on a regular/daily basis.
- 2.) Fill in a Horse Health FEI Self-Certification form for all horses attending the FEI Event. To be filled out and submitted via the FEI HorseApp the day before or the day of arrival at an FEI Event.
- 3.) Take the temperature of each horse twice a day at the FEI Event using your own thermometer and record the measurements directly into the FEI HorseApp.

Access to the FEI HorseApp is also available for your Grooms and Support Personnel, so they can also enter the daily temperature recordings of your horses. They can connect to the FEI HorseApp with their FEI ID number. If they do not yet have a FEI ID number, they can create one. Non-compliance with the FEI Veterinary Regulations and Horse Health Requirements will result in sanctions. These sanctions are already in force for Horses competing at FEI Events in Mainland Europe and will be introduced worldwide in due course.

If a horse cannot participate in the Award Ceremony for safety reasons, permission to not participate must be given by the OC/Chief Steward/Ground Jury prior to the ceremony. Please be on time for your award ceremony.

DESERT INTERNATIONAL HORSE PARK IMPORTANT NATIONAL CLASS INFORMATION

AMATEUR CLASSES (AA):

- Individuals possessing current amateur certification are only eligible as Adult Amateurs from the beginning of the calendar year
 in which they reach age 22. Only active United States Equestrian Federation members may obtain amateur status.
 (Exception: Equine Cana da members in possession of current EC membership may sign for USEF Amateur status on a
 show-by-show basis at no cost).
- Participants must possess current USEF Amateur status and qualify under the USEF Amateur rules.
- If opportunity classes at Dressage Competitions are restricted to amateurs, riders are required to have amateur status with USEF.

JUNIOR/YOUNG RIDER CLASSES (JR/YR): Riders are eligible to compete in these classes until the end of the calendar year in which they reach the age of 21.

PONY MEASUREMENT: The pony division is open to all breeds that meet the following measurement requirements. In the Dressage Division, a pony is an animal that does not exceed 148 cm (14.23 hh) without shoes, and 149 cm (14.27 hh) with shoes. The pony can be of any sex (Mare, Stallion, or Gelding).

- Ponies under the age of eight and in possession of a valid temporary card from another division or discipline should submit
 a copy with their entry.
- Measurement will be required for these pony specific classes if they do not currently have a valid measurement card. Measurement will be yearly beginning from the age of three (36 months) until the pony has reached the age of eight years. Animals three through seven years old will be issued an annual Temporary Certificate of Measurement and must be re-measured annually until the age of eight years. Animals eight years and older will be issued Standard Certificates of Measurement which will not need to be renewed. Measurement must be completed on USEF Combined Driving and Dressage Pony Measurement form. Individual responsible for presenting the pony for measurement must be 18 years old. Animals submitted for measurement or re-measurement must show no evidence of lameness and must be jogged for soundness prior to the measurement. Animals showing evidence of lameness are not eligible for measurement or re-measurement.
- The pony must be entered to compete at the competition for a measurement to take place.
- When the competition veterinarian is on call and an alternative measurement time is necessary, management must receive
 a written request for measurement from the owner or agent at least five days prior to the start of competition to set up a
 time.
- It will be the pony owner's responsibility for the fee charged (if any) by the veterinarian. This must be done prior to first ride.

CLASSES PER DAY: Horses are limited to a maximum of three Dressage rides per day at Fourth Level and below or two Dressage rides per day above Fourth Level. Horses competing at both Fourth Level and Prix St. Georges, or their equivalents, are limited to two Dressage rides per day. Dressage Seat Equitation, Quadrille, Pas de Deux and Materiale classes are excluded from the maximum limit of rides per day and horses in these classes may compete at any level for which they are otherwise eligible during the same competition.

CONSECUTIVE LEVELS: Horses may enter no more than two consecutive levels, Freestyle levels included, at any one competition.

ARENA SIZE: All classes will be conducted in a standard-sized arena (20 m x 60 m).

CURRENT RULES: The rules may have changed from the current USEF Rule Book. It is the competitor's responsibility to check the current USEF Rule Book for any changes. Current rules can be found on www.usef.org.

AWARDS FOR NATIONAL CLASSES: Ribbons to third place for each class. Divisions (JR/YR, AA, Open) may be run concurrently as one class. Divisions will be pinned separately. Riders must clearly specify division choice. When no designation is made, riders will automatically be entered as open. Riders may enter only one division per class.

Six High Point Champion ribbons and prizes will be awarded. One Training through Fourth Level winner in each division - Open, AA, JR/YR and one FEI winner in each division - Open, AA, JR/YR. Freestyles, Intro Level, Dressage Seat Medal (DSE), Young Horse, and Materiale classes do not count towards HP awards.

DESERT INTERNATIONAL HORSE PARK ENTRY INFORMATION

ENTRY INFORMATION REQUIREMENTS: Competitors are responsible to provide valid membership numbers on the entry form for all horse, owner, rider, and trainer names listed on the entry form. USEF and USDF registration is verified electronically if valid membership numbers are provided on the entry form. You may be asked to provide copies of your membership documents if your memberships cannot be verified for any reason. All hard copy entries must include copies of all memberships for horse, owner, rider and trainer listed on entry form.

NO ENTRIES WILL BE ACCEPTED WITHOUT MEMBERSHIP CARD COPIES: No horse will be permitted on the grounds without proof of vaccinations (Equine Influenza Virus & Equine Herpes Virus (Rhinopneumonitis) no later the 180 days prior to arriving. Rule GR844.

ENTRY AND ENTRY DEADLINE: ALL ENTRIES MUST BE DONE ONLINE AT <u>WWW.EQUESTRIAN-HUB.COM</u>. Entries must be received by Midnight of the closing date in the time zone of the competition. Any entry requiring a signature, payment, or copies of proof of valid membership will be considered incomplete and may incur additional fees. No refunds after closing date, for any reason.

- All fees must be paid in US funds. Fees must accompany the entry form for each show entered. Entries not accompanied by
 fees will be considered late and not entered until fees are received including any late or post entry fees.
- Entries postmarked or submitted after closing date will be considered late. Numbers will not be given out until entries have been submitted to the show secretary AND owners, riders and coaches or trainers have signed all entry blanks.

All entries for Open Classes are taken on a first-come, first-served basis. Only one horse-rider combination per entry form.

LATE ENTRIES: Late entries will be accepted after the closing date if space is available, upon payment of an additional late entry fee.

POST ENTRIES: Entries will be accepted to fill scratches, up to the start of competition, if scheduling permits. No late entry fee will be required but will be required to pay a post entry fee in addition to the normal class fee.

POLICY FOR ACCEPTING POST ENTRIES AND FILLING SCRATCHES IN CLASSES: Must be eligible for class. Must have previously entered in competition as a competing or non-competing horse. Must register with secretary and put name on wait list. Post entries in national classes will only be accepted to fill scratches in allotted time slots that are available ("allotted time" slots are determined by the official schedule posted at the show office). Exceptions will be made when two or more competitors meet the same criteria and are deemed equal in priority status. Exceptions may also be made when conditions are created by weather or other natural disasters.

TRAILER PARKING: on grounds.

MUSICAL FREESTYLES: Music must be on good quality MP3 file and emailed to the show secretary (please include rider/horse and class): All music must be submitted to show office or emailed prior to packets being released. The schedule for sound checks will be posted at the show. All Freestyle entries Training-Fourth Level must submit proof of at least a 63% at the highest class of the level and all FEI at least a 60%. CDI Freestyle Music must be uploaded to the BlackHorse rider dashboard (Equestrian-Hub).

Numbers must always be worn when a horse is being exercised or ridden.

Show Management reserves the right to vary or add officials and refuse any entry for a cause; to disqualify any exhibitor and/ or his or her horse for cause; to cause an exhibitor to forfeit his or her ribbons and winnings for cause; to return any entry and/or stall fee before or during the show for cause; all without being liable for damage or compensation. Show management reserves the right to make any changes deemed necessary for the safe and efficient conduct of this competition.

REFUNDS: There are no refunds or credits possible after the closing date listed in the prize list. If you cancel before the closing date your entry will be refunded minus an office fee.

WEATHER/ACTS OF GOD/ACCIDENTS OR EMERGENCY POLICY: Management reserves the right to cancel any classes due to hazardous weather, Acts of God, Accidents or Emergencies. Every effort will be made to reschedule with priority given to CDI or USEF Program classes. No refunds for cancellations due to hazardous weather, Acts of God, Accidents or Emergencies.

NO SHOWS: All "No Shows" that have not contacted the show office will be considered a scratch for the rest of the show and time slots may be filled. Exhibitors enter with this understanding and agreement.

Horses must have at least a USDF HID number to show (\$45 after 12/1/2024). For GAIG/USDF qualifying the horse needs a USEF life or annual membership and a USDF life membership. Horses with only an HID are not eligible. Show Pass Fee ***Effective 12.1.2022*** Any rider, handler, driver or owner is limited to one Show Pass purchased annually (December 1 - November 30). USEF Show Pass will be available for purchase by exhibitors on-line "ONLY" here: https://www.usef.org/show-pass 7-days prior to the show. Individuals, including parents who are signing as trainer on behalf of a minor, who are participating as a trainer or coach are not eligible for a Show Pass and must obtain a Senior Competing membership to participate in a USEF- licensed competition.

GREAT AMERICAN INSURANCE GROUP (GAIG)/USDF QUALIFYING CLASSES: Please indicate that the class is to count for qualifying by placing a Q after the class number on your entry. Qualifying does not require a separate ride. An exhibitor riding in the Open, AA or J/Y rider classes must pay an additional \$20 USDF fee to have this score entered in the GAIG/USDF qualifying division at that level.

SHOW SCHEDULE AND RIDE TIME CONFLICTS: It is the responsibility of the rider to inform the management of any time conflicts as soon as possible after receiving the schedule. Organizers cannot guarantee that CDI draw times will not conflict with open class times. Changes need to be requested in the show office by 3pm the day prior.

RIDE TIMES & SCORES: Will be available on www.equestrian-hub.com.

EQUINE CANADA: All Equine Canada competitors with a current Equine Canada membership must also have a complimentary USEF membership. If your Equine Canada membership is current for the show year, then the USEF membership will be No Charge. This rule change pertains to all Canadian riders, owners and trainers. Please see membership details at USEF.org. You will also need a USDF membership, or a Non-Member Fee (\$55) will apply to each rider, owner and trainer

EQUIPMENT INSPECTIONS: DR126.2: New rules regarding equipment checking. TD is responsible for checking a minimum of 50% of the assembled bits and bridles of horses entered. This should be done primarily in the barns or haul-in area. The TD may conduct some full equipment checks at the arena after the test has been completed.

MICROCHIP REQUIREMENT: GR1011.10: Effective <u>December 1, 2025</u>, all horses competing at USEF Federation Licensed and Endorsed competitions must provide a microchip number that verifies the animal. A microchip used to verify the identity must be a fifteen-digit ISO compliant 11784/11785 chip and implanted in the nuchal ligament of the animal. Microchips must be implanted 12 hours prior to the horse competing or once the horse is done competing in accordance with GR414.

USEF MICROCHIPPING RULE EFFECTIVE 12/1/2025

GR 1101.10, all horses competing in USEF-licensed or -endorsed competitions must be microchipped with a 15-digit ISO compliant 11784/11785 chip.

Rule Overview

As a reminder, this rule will require <u>all</u> horses to have a microchip to be eligible to compete at a USEF licensed competition, including dressage competitions. This microchip number must be on file with USEF and, once recorded, will remain with the horse's record. Microchip numbers do not need to be collected by the competition. <u>It is the participant's responsibility to report the microchip to USEF</u>, but we will ask competitions to verify that a chip number is on file before accepting the entry.

Reporting Tool

USEF has an online microchip reporting tool which can be used to report a microchip for a horse by anyone (i.e. owner, trainer, barn manager, secretary). Once reported, the microchip will be instantly added to the horse's account and the records will update to show the horse is compliant.

For current Non-Members -

For Owners of a horse entered in Opportunity or USDF Introductory classes (A, B, C) these horses are no longer exempt from the USEF Horse Registration requirement. <u>All horses</u> must have, at minimum, a USEF horse ID. Please see steps below to follow if you are in this category.

Owners will be able to get a free fan account which can remain inactive, then they will apply for a horse ID which is also free. They can follow these steps:

• To complete a new horse recording/horse ID, log into your account at www.usef.org. Navigate to your dashboard, found by hovering over "Account" in the top right corner of the page, and select "My USEF Dashboard." Once you are on your dashboard, scroll halfway down the page until you see a section titled "Horse Options." Select the tile "Create New Horse" with the '+' symbol on it. The first question asks if this application is related to a show; select yes or no. Then you will begin the application process. Once you have submitted the application, it will move to your online shopping cart which will be accessible from the "Account" menu, this time with a red dot indicating you've moved the application to your cart. Once you check out the recording/horse ID from your cart, the application will be submitted to our office for processing.

When creating the USEF Horse ID it will allow the owners to input the microchip number and should be good to go! The fan account is sufficient to obtain an ID and they will not need to upgrade to competing unless the horse is competing in a section that is not member exempt.

The scores of competitors who fail to supply correct numbers may not be counted towards national awards.

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races: 4) classes for 4-H members: 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding class

FEDERATION ENTRY AGREEMENT

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaulter or Lungeur and on behalf of myself and my principals, representatives,

employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of the competition. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question

arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules.

I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/

or the Competition may use or assign photographs, videos, audios, cablecasts, broadcasts, internet, film, new media

or other likenesses of me and my horse taken during the

course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation.

The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

CURRENT RULES: The rules may have changed from the current USEF Rule Book. It is the competitor's responsibility to check the current USEF Rule Book for any changes. Current rules can be found on www.usef.org.

GOLF CART/MOTORIZED VEHICLE RULE: In accordance with GR1301.7:

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or quardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. A trainer is defined as any adult who has responsibility for the horse on the competition grounds and must sign the entry form.

PROTECTIVE HEADGEAR RULE: From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds including noncompeting riders, riders on non-competing horses and those competing in all classes and tests must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must be immediately prohibited from further riding until such headgear is properly in place. Protective headgear is defined riding helmet which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. The harness must be secured and properly fitted.

IMPORTANT NOTICE TO ALL AFFECTED PARTIES:

Third parties may come upon the property or enter the facilities where any herein described or listed event will occur; provided, that this is a license to enter the premises, for the purpose of observing or participating in the event, but not otherwise, and such license to any individual is subject to revocation by the owner, lessee or organizer, and entry for any purpose other than granted herein, shall be deemed criminal trespass and subject to appropriate legal proceedings.

NO SHOWS: All "No Shows" that have not contacted the show office will be considered a scratch for the rest of the show and time slots may be filled. Exhibitors enter with this understanding and agreement.

SHARPS DISPOSAL: Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments. A non-member may participate as a handler, rider, driver, owner, lessee or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; and 7) assistant handlers in Dressage Sport Horse Breeding classes.

MOTORIZED VEHICLE STATEMENT

GR1301.7-8: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

PART I: Mandatory Requirements for Accessing the Desert International Horse Park

1. Entering the Desert International Horse Park (DIHP)

- a) All horses entering and staying at the Horse Park must be entered in the horse show, registered/recorded (with a USEF, FEI, and/or Equine Canada horse ID number), and have an assigned DIHP 2025/2026 back number.
- b) Horses competing exclusively in FEI classes and accessing the Horse Park must go directly to FEI stabling and follow FEI entry protocols.
- c) <u>All CALIFORNIA owners/trainers</u> must submit the following documents to enter the Horse Park, via the biosecurity link on our website, <u>a minimum of 48 hours in advance of arrival</u> for all horses entering the Horse Park:
 - i) Equine health declaration document signed by the owner/trainer, within 7 days of horse(s) arrival at DIHP, stating each horse indicating has not had a fever (defined by greater than 101.5°F) or clinical signs of disease within the 72 hours before arrival, has not been exposed to or treated for a fever of unknown origin within the past 30 days. Any horse tested for EHV-1 in the last 30 days has tested negative for EHV-1 twice in the previous 30 days by an approved, accredited laboratory.
 - ii) No USDA-accredited CVIs are required for horses originating/residing in the State of California to enter Desert International Horse Park at this time. Coggins tests are not required for California horses but they are encouraged as part of your horse's regular health management program.
 - that the horse is compliant with all vaccination requirements of USEF GR 844 (supporting documents required to be in hand). GR 844 requires that at Federation-licensed competitions, horses more than seven (7) months of age entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six (6) months before entering the stables. No grace period will be allowed for expired vaccination guidelines. If your horse's Rhino/Flu vaccinations expire while your horse is at DIHP, we ask that you update their vaccinations on site with the East-West Veterinary group or a private veterinarian. Please submit documentation to support their updated vaccination status to:

 - iv) After completing a mandatory arrival submission, you may upload the requested documents to our document submission platform via the biosecurity link on our website. Entrants will be required to read, acknowledge, and agree to the biosecurity practices and protocols in place at the Horse Park. Refer to page 5 for the portal links mentioned on our website.
- d) All Out-of-State/non-California and International horses must submit the following documents to enter the Horse Park a minimum of 48 hours in advance of arrival for all horses entering the Horse Park:
 - i) Official State Issued or Approved International Certificate of Veterinary Inspection (CVI) with an inspection date, by an accredited veterinarian, within seven (7) to ten (10) days of arrival for out-of-state horses and 14 days for international horses. For horses entering from outside the State of California, a CVI and a valid Coggins test performed within the previous 12 months are

required to enter the state. Health certificates issued in Canada that meet USDA requirements for entering the United States will be accepted for entry into the DIHP. **Every CVI must include the following statement:**

- (1) "I declare that the horse listed below is not demonstrating any signs of EHV-1, has not had any known exposure to EHV-1 in the past 30 days, and is not coming from a property with known EHV-1 positive cases."
- ii) Equine health declaration document signed by the owner/trainer, within 7 days of horse(s) arrival at DIHP, stating each horse indicating has not had a fever (defined by greater than 101.5°F) or clinical signs of disease within the 72 hours before arrival, has not been exposed to or treated for a fever of unknown origin within the past 30 days. Any horse tested for EHV-1 in the last 30 days has tested negative for EHV-1 twice in the previous 30 days by an approved, accredited laboratory.
- that the horse is compliant with all vaccination requirements of USEF GR 844 (supporting documents required to be in hand). GR 844 requires that at Federation-licensed competitions, horses more than seven (7) months of age entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six (6) months before entering the stables. No grace period will be allowed for expired vaccination guidelines. If your horse's Rhino/Flu vaccinations expire while your horse is at DIHP; we ask that you update their vaccinations on site with the East-West Veterinary group or a private veterinarian. Please submit documentation to support their updated vaccination to biosecurity@deserthorsepark.com
- iv) When the above documents are submitted, entrants must read and acknowledge the practices and protocols at the Horse Park.
- e) All owners/trainers must sign up for a scheduled arrival time via www.deserthorsepark.com at least 48 hours in advance. Upon arrival, the Driver must present a list of horses on board that matches the documentation submitted to the Horse Park. Depending on the risk, as determined by DIHP, USEF, and CDFA, all arriving horses may receive a visual inspection for signs of infectious diseases. Only healthy horses will be permitted entry to DIHP.

- f) Horses leaving the property and returning must complete updated <u>arrival submissions</u> and declarations of health statements for re-entry as follows:
 - i) Horses leaving and returning within five (5) days of leaving DIHP may return with updated declarations and/or vaccination records, assuming the vaccinations are valid through the circuit. An additional inspection of the horse may occur upon entry.
 - ii) If the horse competes as a daily haul-in, twice-daily temperature checks must be conducted and recorded off-site, and their temperature logs must be available upon request throughout the competition. Additionally, an updated declaration of health for all horses must be completed on a weekly basis. Horses may be inspected daily. All daily haul-in horses are required to have a temporary stall on site. Haul-in horses are no longer allowed to be left alone in our parking lots or remain on trailers during their stay at DIHP.

- iii) <u>Horses leaving one circuit week and returning for another circuit week, you</u> must complete a new arrival submission and document submission, including a new declaration of health and vaccination forms.
- g) If documents aren't available for pre-submission, they may be presented at the gate, which can delay inspection and unloading. If documentation is missing or unavailable, DIHP reserves the right to refuse entry to the Horse Park or to require the horses to proceed to a designated area until the completed documentation is submitted -- up to a maximum of 24 hours. After 24 hours, any horses not meeting documentation requirements must leave the Horse Park.

PART II: Requirements for Monitoring Horses at the Horse Park

2. Monitoring Your Horses While at the Horse Park

- a. INITIAL MONITORING REQUESTED DURING ARRIVAL AT THE HORSE SHOW
 - i. Temperature checks for horses will <u>not</u> be conducted upon arrival at the front gate of the Horse Park. <u>Additionally, 3-day temperature logs are not required to be presented at the</u> <u>front gate</u>. However, in the event of an elevated disease risk, management may require temperature checks upon entry and the maintenance of temperature logs.
 - ii. Once a horse is settled in, a first temperature check should occur before leaving the stall for initial work. This initial check should occur within 3 to 6 hours of arrival.
 - iii. If an initial temperature check reveals a fever (defined as 101.5°F if the horse is not on an NSAID or 101.1°F if the horse is on an NSAID or other temperature-suppressing medication), then DHIP should be notified, and the horse should remain in the stall until the show veterinarian or the biosecurity officer takes a subsequent temperature.
 - iv. The show vet and biosecurity officer must be informed of the initial elevated temperature by a USEF mandatory fever reporting rule effective December 1, 2024.

 Non-compliance would be a violation of this USEF rule.
 - DIHP reserves the right to isolate and/or test any horse with a fever and/or clinical signs for EHV-1 or any other infectious diseases at the owner's expense. Individuals who fail to isolate and or test when requested may be required to leave the event grounds.
 - 2. DIHP may require a test for EHV-1 after the first or second temperature check based on the clinical presentation and epidemiologic risk assessment.

b. DAILY MONITORING OF HORSES DURING THE HORSE SHOW

- i. <u>Twice daily temperature checks, morning and evening, are requested during the horse's stay at the horse park.</u>
- ii. Trainers/owners are required by the USEF mandatory reporting rule to notify the show vet and the show office of a horse with an elevated temperature per a new mandatory USEF rule (defined as 101.5°F if the horse is not on an NSAID, or 101.0°F if the horse is on an NSAID or other temperature-suppressing medication). If a horse has an elevated temperature, it must stay in its assigned stall. If the horse has no other clinical signs, it may be allowed to remain in its stall, and a temperature will be taken 4-6 hours later. If the horse remains febrile (exhibiting an elevated temperature as described above) or shows signs of infectious disease, the show veterinarian or biosecurity officer must be notified immediately.
- iii. <u>DIHP reserves the right to require isolation, within a timely manner (less than 2 hrs), and to require testing of any horse with a fever and/or clinical signs for EHV-1 and other infectious diseases.</u>
 - At any time, if the DIHP show veterinarian, the biosecurity veterinarian, and/or competition management deems that a febrile horse may pose an infectious disease risk, the horse shall be moved to isolation to protect the health of the horse and the general health of the equine population on the competition grounds.
- iv. If the trainer and/or owner refuses to send the horse to DIHP isolation, the horse and its cohorts may be asked to leave the competition grounds immediately by DIHP management. Failure to abide by these rules will be cause for referral to USEF for enforcement.
- v. Horses in isolation will be released from isolation based on a collective decision of the DIHP show management, the biosecurity veterinarian, the East-West Veterinary Group, and USEF. Decisions will be based on the horses' diagnostic test results, the absence of abnormal clinical signs, and epidemiologic risk assessment.
- vi. During the next seven (7) days, the show vet or horse show biosecurity officer will oversee the temperature check of all horses in the trainer's cohort to ensure no additional fevers develop. If additional horses are febrile or displaying clinical signs of infectious disease, these horses may be required to report to the isolation area or may request permission to leave the premises for isolation.

PART III: Desert International Horse Park Biosecurity Practices

3. Biosecurity Practices During the Horse Show

- a. Overall Biosecurity Practices
 - i. A nighttime curfew will be in place each evening at 9:00 p.m. Noise must be kept to a minimum in the barn/tent area, and unnecessary lights will be turned off.
 - ii. The Horse Park will maintain hand sanitizing stations at each barn/tent entry and ringside. All individuals working with horses are encouraged to clean their hands as frequently as possible.

- iii. To the best extent possible, tack, rider clothing, horse tools/rags, etc., should be dedicated to a unique horse and not shared across horses.
- iv. Grooms, riders, and trainers should maintain a safe distance between horses throughout the property and avoid sharing items such as rags and buckets between horses.
- v. The Horse Park will regularly clean and disinfect common areas, including wash racks, shade structures, and hoses.
- vi. Signage will be located throughout the Horse Park detailing best practices and required protocols.
- vii. DIHP will also perform vector control throughout the barns, tents, and other populated

b. Biosecurity Practices Across Trainer Cohorts

- i. Access to each barn/tent should be limited to individuals with horses in the respective barn/tent.
- ii. Grooms, trainers, and riders should take every precaution to avoid contamination across trainer groups. This includes not sharing any tack, cleaning material, brushes, etc., even when it's the "nice" thing to do.
- iii. When crossing trainer groups, grooms/trainers/riders are encouraged to change clothes and practice basic cleaning procedures, such as washing and/or disinfecting their hands, boots, and other equipment.

c. Biosecurity Practices at the Ring and/or Other Common Areas

- i. Grooms/riders/trainers should keep space between horses.
- ii. Extreme caution should be taken by those handling/riding horses to avoid contamination between horses. Tack should not be shared across horses. Riders transitioning from one horse to another should wash their hands with soap and water or use a disinfectant. Materials used to care for horses, e.g., towels or rags for wiping noses, should not be shared between horses.
- iii. Cleaning/sanitizing stations will be located throughout the competition area for grooms/trainers/riders to use.

d. Biosecurity Practices for Third-Party Providers (including vets, grooms, farriers, braiders, night check, equine spa service, horse exerciser, etc.)

- i. All third-party providers operating within the Horse Park are required to disinfect their tools and work areas before moving between barns, tents, and trainer groups.
- ii. Braiders, vets, farriers, and night checkers are required to clean and disinfect their hands, clothing, and shoes between horses.
- iii. Night check is requested to disinfect their shoes between barns/tents and use PPE if working with an individual horse.
- iv. Equine spa service vendors must sanitize spas after each usage, have separate handling equipment for each horse, and require spa employees to sanitize their hands, clothing, and shoes between horses.
- v. The IDA horse walker will be available for use by trainers/horses on the property. Only horses from the same barn may use the horse walker at the same time. IDA is required to disinfect the horse walker when subsequent horses are from a different barn..
- vi. All third-party providers shall maintain a list of horses worked on, which must be provided to management or state officials upon request in the event of an infectious disease incursion.

e. Biosecurity Practices at Vet and Farrier Stations

- i. Cleaning stations will be set up at the vet clinic and the farrier station.
- ii. Vets and farriers are required to clean and disinfect (including shoes) between horses.
- iii. The Horse Park will regularly clean and disinfect the vet clinic and farrier station using a long-term disinfectant.

f. Rules for FEI

i. Standard <u>FEI protocols</u> for FEI competing horses must be followed, in addition to adherence to DIHP protocols.

PART IV: Procedures in the Event of a Positive EHV-1/EHM Horse(s)

4. What Happens If a Horse Tests Positive for EHV-1?

- a. If a febrile horse tests positive for EHV-1 on a rapid test, it will be immediately moved to an isolation barn within 2 hours or less. A confirmatory PCR test will be conducted, and the horse will remain in isolation while awaiting these results. Additional testing for EHV-1 and a detailed treatment plan will be provided based on a collective decision of DIHP management, the biosecurity veterinarian, USEF, and the East-West Veterinary Group.
 - No horse in isolation will be permitted to compete. An exercise plan for an isolated horse will be set forth by the show veterinarian and/or biosecurity veterinarian.
- b. At a minimum, an EHV-1-positive horse must remain in isolation until it has been afebrile for 72 hours without any antipyretic medications and has had two validated/confirmed negative tests for EHV-1.
 - If the horse becomes febrile again, it will remain isolated until it has reached the 72-hour afebrile rule and the two validated/confirmed test rule has been satisfied.
 - ii. Once this has occurred, the horse will be returned to its stall and is free to resume exercise and competition at the discretion of the horse owner/trainer/veterinarian.
- c. The trainer/owner of a horse testing positive for EHV-1 may elect to have the horse undergo isolation at home, subject to adherence to recommended guidelines from the show veterinarian and the biosecurity officer.
- d. <u>Horses testing positive for EHV-1 may be encouraged to begin antiviral treatment and zinc/lysine supplementation to reduce their risk of developing EHM based on discussions with the biosecurity officer and the East-West Veterinary group.</u>
- e. Additional biosecurity protocols will be implemented for the cohort (barn/tent) of the EHV-1 positive horse. Twice-daily temperature logs will be monitored by the show veterinarian and/or the show biosecurity officer for a period of seven (7) days. Access to the cohort (barn/tent) may be limited and enforced by the Horse Park. Foot baths and additional stall disinfectant applications may be used at the discretion of the Horse Park. These precautions may remain in place for up to seven (7) days, assuming no additional febrile horses are identified.

- f. Asymptomatic horses within the cohort will be free to exercise and compete during this period as long as their temperatures remain less than 101°F before they leave their stalls. Based on epidemiologic risk assessment, additional restrictions and testing may be required for the cohort population.
- g. Should additional horses from the cohort become febrile, they will be tested for EHV-1 at their stalls, and a Fluxergy rapid test will be performed. If the horses test negative, those with an elevated temperature may be required to report to isolation, based on a collective decision by DIHP management, the biosecurity officer, USEF, and the East-West Veterinary Group.
- h. Should a second horse in a cohort test positive for EHV-1, the entire cohort will be under Horse Park quarantine for seven (days) after the positive horses have cleared isolation and no other horses in the cohort are febrile or are showing clinical signs. All horses in the cohort will be required to stay in their stalls and adhere to a restricted exercise plan.
 - i. Positive horses will be relocated to a designated isolation area on a case-by-case basis.
 - ii. Horses will be monitored until no additional fevers have been identified and all positive EHV-1 horses from that cohort have been cleared. During this time, the Horse Park will conduct additional monitoring of the barn/tent.
- i. The Horse Park's quarantine isolation procedures include fencing around the barn/tent, security personnel, and limited access.
- j. Exercise arrangements for horses in isolation or exposed barns may be limited and will be made at the discretion of the Horse Park. Horse health and welfare will be the priority in managing the isolated and exposed horses.

5. What Happens if We Have a Case of EHM?

- a. If a febrile horse (or one positive for EHV-1) exhibits additional clinical signs consistent with EHM, the horse will be immediately moved to an isolation tent, and the USEF and CDFA will be notified. The horse will undergo a rapid EHV-1 test. Should the horse test negative, it will remain in isolation until a confirmatory PCR test is performed 48 hours later by the CDFA lab.
- During this time, the show barn/tent will be placed under precautionary biosecurity protocols, including foot baths, vet-monitored temperature checks, and further limited access.
- c. If the neurologic horse tests positive for EHV-1, the CDFA will assume responsibility for quarantine and other protocols until the Horse Park is officially released from state quarantine and restrictions..

6. What Happens if a Horse Shows Signs of Vesicular Stomatitis (VS) or Screwworm Disease?

- a. Screwworm and Vesicular Stomatitis are regulatory diseases and, as such, have required protocols designated by state and federal animal health officials.
- b. The affected horse will be immediately moved to our isolation area, and all cohorts will be examined for similar lesions. The CDFA and USEF will be notified, and the affected horse will be tested for VSV or treated for screwworm infestation. All further actions taken by DIHP will be determined upon consultation with the CDFA and USEF.

Part V: Working Together to Keep Horses Safe to Keep Horses Safe

7. DIHP – Our Part

- a. The DIHP has hired a biosecurity officer who is a licensed veterinarian. Importantly, our biosecurity officer is not on the grounds to treat horses. The show vet, East-West Equine Sports Medicine, is responsible, along with your vet, for treating your horses. The biosecurity officer will guide the implementation of protocols, obtain feedback, and assist when needed, ensuring that all involved, from Horse Park staff to participants, adhere to the necessary daily measures to maintain the health and well-being of all horses on Horse Park grounds.
- b. We will ensure the Horse Park is regularly cleaned and sanitized, especially in high-traffic areas. Whenever the occupant of a stall changes, we will repeat the disinfecting process. You can be assured they are as clean as we can make them. Please let us know if you find something that is not clean or if you have concerns.
- c. We will implement rigorous vector management controls to mitigate the risks posed by flies, gnats, and other pests.
- d. We will ensure we are prepared if a horse contracts EHV-1. We have learned a great deal about best practices for treating horses and are confident that our veterinary partners at East-West Sports Medicine are well-trained and prepared. We'll support them and ensure that all the supplies and medicine needed are on the grounds for immediate use.
- e. <u>DIHP will report all horses entering isolation to the USEF as required. All EHV-1</u> positive cases will be reported to USEF, and all instances of EHM will be reported to both USEF and CDFA.
- f. <u>DIHP will ONLY provide general press releases regarding EHV-1/infectious diseases onsite if:</u>
 - 1. There is evidence of disease agent spread to one or more trainer cohorts on the venue grounds. A single isolated case of an infectious disease will not generate a press release.
 - 2. A partial/entire show barn has been quarantined for a contagious disease.
 3. Epidemiologic investigation deems a high risk of disease transmission onsite or a high risk of disease incursion due to the presence of the disease agent in the geographic area.
- g. Any decision to limit, postpone, or cancel a competition, as well as subsequent decisions to resume competition, will be made in consultation with the USEF and CDFA.

8. Participants – Your Part

- a. If you suspect a horse with an elevated temperature may be sick, **do not** bring it to the Horse Park until things are resolved. If your horse becomes ill at the Horse Park, please immediately notify the show veterinarian, biosecurity officer, and competition management, as required by USEF. The single most important thing that can be done is to isolate sick horses as soon as possible and provide them with appropriate care. It is good for the horse and good for all the other horses as well. The Horse Park staff are here to assist you.
- b. While at the Horse Park, practice common sense and good hygiene protocols, as well as follow DIHP biosecurity protocols, which are in place to ensure the health and welfare of all horses on the premises.

DESERT INTERNATIONAL HORSE PARK

EQUINE HEALTH AND BIOSECURITY REQUIREMENTS

Up-to-date DIHP Biosecurity Protocols and Practices are available online at deserthorsepark.com. These new protocols and practices have been developed in consultation with UC Davis, CDFA, and US Equestrian. The new protocols and practices will require additional documentation regarding the health of horses arriving at the DIHP. These include the following below:

1) PROOF OF VACCINATION AND COMPLIANCE WITH GR844

Required

Via a signed statement from the attending veterinarian that the horse has been vaccinated against the following:

Within 6 months (180 days) of each show: Equine Influenza (EIV)

Within 6 months (180 days) of each show: Rhinopneumonitis (EHV-1 and EHV-4)

If a vaccination will expire during one of the shows, the horse must receive its new vaccination prior to being issued a competition number for that show. Statement of vaccination must be on Official veterinary Letterhead and must contain the Show Name of each horse.

If the vaccine has been administered by a person other than a veterinarian, the exhibitor must provide, upon request, a receipt of the vaccine purchase which is signed by the owner, or agent with care, custody, and control of the horse; the name, serial number, and expiration date of the vaccine; and the date of the vaccine administration.

2) INTERSTATE OR INTRASTATE HEALTH CERTIFICATE (CVI)

Required

This document must be submitted prior to the arrival of the horse to the showgrounds. It must be an official state CVI and must indicate the horse's registered (show) name, and be signed by an accredited USDA veterinarian within 5 days of arrival.

The CVI must include the following statements:

- 1) "I have examined the animal(s) represented on this Certificate of Veterinary Inspection and have found no clinical signs of vesicular stomatitis and they have not originated from premises under quarantine for vesicular stomatitis."
- 2) "I declare that the animal(s) represented on this Certificate of Veterinary Inspection are not demonstrating any signs of EHV-1, have not had any exposure to EHV-1 in the past 21 days, and are not coming from premises with known cases of EHV-1."

3) USEF DECLARATION OF HEALTH

Via a signed statement by owner/trainer for each horse declaring that:

- a) Horse has not had a fever above 101.5 or (101.1) if the horse is taking NSAIDs or any other fever suppressing treatment drug during the last 72 hours.
- b) Horse has not been exposed to or treated for a fever of unknown origin within the last 28 days
- c) Horse has received a negative EHV-1 test within the last 30 days if it had previously tested positive during the past 6 months

DIHP FACILITY CREDENTIALS



All individuals need to be credentialed in order to be on the Desert International Horse Park property. Each individual will receive a photo ID that will be scanned upon entrance and exit.

HOW DO I GET MY CREDENTIALS?

Individuals can go to the website, sign the required documents and submit for credentials.

ID badges will be printed at the main gate or show office at the beginning of the show week

WHAT ARE THE CREDENTIALS?

Each individual will have a unique photo ID. You will be required to have it on you at all times, though not visible.

HOW LONG DO MY CREDENTIALS LAST FOR?

Once completed, the process only needs to be done once for the entire season. Credentials issued for the previous seasons remain valid if the original information on the submittal has not changed.

I understand and agree that Released Parties (as defined below) cannot guarantee: (a) the protective measures can or will prevent my exposure to COVID-19; (b) will be complied with by all individuals at the Facility; or (c) that others will not act in a negligent manner that may contribute to my Loss or contraction of COVID-19. 2026 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at www.usdf.org. Please refer to the 2026 USDF Member Guide for the comprehensive list of rules and requirements for this program.

Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

Rider:

- Must have a USDF Participating* Membership (PM).
- Must have a USEF membership (Active or Life).

Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s). A horse is not required to have breed registry papers.
- Horses must be entered in qualifying and championship classes under their official recorded names and ownership as specified in USEF GR1102.3, and transfers of ownership or lease registrations must be completed in compliance with USEF rules GR1105 and GR1108 prior to the competition in order for the horse to compete under the name of the new owner or lessee. (USEF DR127.2)

Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Active or Life Membership or Annual Recorded Farm/Business (with Senior Active Competing Farm Owner in good standing)). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.
- * PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

Minimum Qualifying Scores: One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. The minimum percentages are as follows:

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those
 sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at
 Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are
 exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot,
 academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM
 identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$100), 5-years (\$400), or life (\$2,000). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$80). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$280) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$55 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$45). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$95. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$140) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF website: www.usdf.org. You can submit the application online or download the form.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.

Regional Adult Amateur Equitation Program

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class presented by Big Dee's Tack and Vet Supply will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition. Ribbons awarded through 8th Place and gift certificates awarded to top four riders.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

Qualifying Requirements

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

a) Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.

or

Qualified to compete in any regional dressage championship class (excluding freestyles).

Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

The USDF Regional Adult Amateur Equitation Program rules and information can be found on the USDF website.
